The Greek subsidiary of a Dutch multinational banking and financial services corporation following an extensive market and operations analysis decided that capturing electronically the signatures of her customers should be part of the electronic application process for registering insurance contracts they were using and her agents will be more efficient in closing contracts if they could get the customer signature right after the customer decided to enroll to an insurance program.

Following development of business requirement, analysis on the EU regulations, available technologies and a lengthy bid process in which capabilities of participating companies, proposed technologies and the time-to-market were evaluated thoroughly, they decided to adopt CubelQ proposal which included **signotec's** electronic signature technology.

Following project award, the new **eSignature** system was completed and delivered in about three months. Project execution consisted of final technical design of **signotec's** software platform operational architecture, installation in high availability in Active-Active mode with load balancing, configuration and parameterization of the platform to accommodate customer broad technical requirement, extensive "hardening" of servers' communication infrastructure based on "best practices" and norms and rules of the mother company, development of system's database on Microsoft® SQL Server™ and development of a number of utility programs covering data transfers between system, monitoring processes and reporting in order to facilitate day to day operation.
